Companies writing property and casualty insurance business in the State of Florida are required to collect a Florida Hurricane Catastrophe surcharge of 1.3% and a Florida Insurance Guaranty Association assessment of 0.8%. ***New Jersey Insurance Guaranty Association Fund:***

***West Virginia Residents:***
